  - (b) the prohibited goods are non-lethal military equipment intended solely for humanitarian or protective use, as approved in advance by the Committee.

### 9B. Licence for provision of certain assistance or training

(1) If satisfied on application that any of the requirements in subsection (2) is met, the Chief Executive must grant a licence for the provision of technical assistance, training, or financial or other assistance related to military activities or to the provision, manufacture,

  - (b) the assistance or training is related to the supply of non-lethal military equipment intended solely for humanitarian or protective use, as approved in advance by the Committee.".

### **Explanatory Note**

This Regulation amends the United Nations Sanctions (Eritrea) Regulation (Cap. 537 sub. leg. AR) to give effect to certain decisions in Resolution 2060 (2012), as adopted by the Security Council of the United Nations on 25 July 2012, by providing for certain exceptions to the prohibition against—

- (a) the supply, sale, transfer or carriage of certain goods; and
- (b) the provision of certain assistance or training.
- 2. The Regulation also makes certain minor textual amendments.
